STEPS TO GET MARRIAGE LICENSE IN WISCONSIN

VIRTUALLY APPLY IN WISCONSIN

• YOU MAY APPLY FOR A MARRIAGE LICENCE VIRTUALLY IN DANE COUNTY, WISCONSIN.

- MARRIAGE LICENSES ARE PROCESSED VIRTUALLY (VIA ZOOM) BY APPOINTMENT ONLY.
- YOU DO NOT NEED TO APPLY IN THE SAME COUNTY YOUR WEDDING TAKES PLACE.
 - IF BOTH APPLICANTS LIVE OUTSIDE WI, THE APPLICANTS MAY ALSO APPLY IN ANY COUNTY IN THE STATE OF WI.
- ALL MARRIAGE LICENSE APPLICATIONS (IN WI) HOLD A <u>3 DAY WAITING PERIOD</u> FROM THE DATE OF APPLICATION.
 YOUR LICENSE WILL BE ISSUED ON THE 4TH CALENDAR DAY FROM THE DATE OF APPLICATION AND IS <u>VALID FOR 60 DAYS</u>.
- YOU MAY APPLY FOR A <u>WAIVER OF THE 3 DAY WAITING PERIOD FOR AN ADDITIONAL \$25 FEE</u>. THE REQUEST/PAYMENT OF THE WAIVER GRANTS THE USE OF THE LICENSE ON THE DATE OF APPLICATION

- PLEASE DO NOT SCHEDULE YOUR MARRIAGE LICENSE APPOINTMENT MORE THAN 60 DAYS PRIOR TO WEDDING DATE.
- YOU WILL RECEIVE A LINK FROM DANE COUNTY TO SCHEDULE APPOINTMENT
 - EACH OF THE REQUIRED DOCUMENTS (SEE BELOW) WILL NEED TO BE UPLOADED INTO OUR SCHEDULING PROGRAM (PDF AND JPEG FILES SEEM TO WORK BEST).
 - HAVE THE ELECTRONIC DOCUMENTS AVAILABLE PRIOR TO GOING THROUGH THE SCHEDULING PROCESS.
 - YOU WILL RECEIVE A ZOOM LINK FOR YOUR APPOINTMENT AFTER YOU COMPLETE THE INFORMATION ON LINK.

• EACH PERSON MUST PROVIDE:

- PHOTO I.D. AND SOCIAL SECURITY NUMBER (WE DO NOT NEED THE SOCIAL SECURITY CARD). IF THE APPLICANT DOES NOT HAVE A SOCIAL SECURITY NUMBER THE SPACE WILL BE MARKED WITH "NONE".
- A DOCUMENT SHOWING YOUR CURRENT PHYSICAL ADDRESS. FOR EXAMPLE: A DRIVER'S LICENSE IF IT CONTAINS YOUR CURRENT ADDRESS, LEASE, UTILITY BILL OR BANK STATEMENT. YOU MUST ALSO KNOW WHETHER YOU LIVE IN A CITY, VILLAGE OR TOWNSHIP AND THE COUNTY WHERE YOU RESIDE.
- A CERTIFIED COPY OF YOUR BIRTH RECORD ISSUED BY THE STATE OR COUNTY WHERE YOU WERE BORN. BIRTH RECORD MUST BE LEGIBLE, NOT TATTERED AND TORN. THE HOSPITAL CERTIFICATE, SCAN OR COPY NOT ACCEPTABLE.
- DATE & LOCATION OF WEDDING: THE DATE OF THE INTENDED MARRIAGE ALONG WITH THE LOCATION. WEDDING DATES NEED TO BE SET PRIOR TO APPLYING FOR THE MARRIAGE LICENSE.
- YOU MUST KNOW HOW TO SPELL BOTH PARENTS' FULL NAMES INCLUDING MOMS FULL MAIDEN NAME.
- IF PREVIOUSLY MARRIED, WE MUST SEE PROOF OF HOW THE LAST MARRIAGE ENDED
- THE LEGAL AGE FOR MARRIAGE IN WISCONSIN IS 18. IF AN APPLICANT IS 16 OR 17 YEARS OF AGE A CONSENT FORM NEEDS TO BE SIGNED BY BOTH PARENTS OR GUARDIANS BEFORE THE COUNTY CLERK.

ON WEDDING DAY - THE FOLLOWING IS REQUIRED

- (2) TWO ADULT WITNESSES (18 YEARS OF AGE OR OLDER) REQUIRED TO SIGN MARRIAGE LICENSE
- OFFICIANT SIGNATURE: OFFICIANT IS REQUIRED TO SIGN MARRIAGE LICENSE
- THE COMPLETED & SIGNED WISCONSIN MARRIAGE LICENSE MUST BE RETURNED TO THE REGISTER OF DEEDS IN THE SAME COUNTY MARRIAGE LICENSE WAS REGISTERED AT WITHIN (3) THREE DAYS AFTER THE DATE OF THE MARRIAGE.
 - CRAZY GIRL LLC WILL BE RESPONSIBLE FOR RETURNING LICENSE TO THE APPROPRIATE REGISTER OF DEEDS
 - AFTER THAT OCCURS, THE CLERK'S OFFICE CAN ISSUE YOU A CERTIFIED COPY OF YOUR MARRIAGE CERTIFICATE UPON REQUEST.
 MARRIAGE CERTIFICATES ARE NOT AUTOMATICALLY SENT TO COUPLES.
 - YOU MAY WISH TO ORDER 5-7 CERTIFIED COPIES OF YOUR MARRIAGE CERTIFICATE, ESPECIALLY IF EITHER OF YOU ARE PLANNING TO CHANGE YOUR NAME.
